

## Differences between competitive vs. noncompetitive

- Competitive permanent titles are those allocated to the competitive division of the career service and are subject to an examination process and successful completion of a working test period. » NJAC 4A:4-1.1
- Non competitive permanent are titles in the career service where competitive testing is not required due to the nature of the knowledge, skills, and abilities associated with the job or difficulties associated with recruiting » NJAC 4A:3-1.2(c).

#### **Competitive Position** - (Identified by magnifying glass)

- Indicates a competitive vacancy to be filled by a civil service test
- Fee to take test

#### **Process**

- Review Job Announcement and Requirements
- Complete Online application
- Look for Eligibility Notice with Test Announcement
- Take Test
- Examination Results Those who pass are ranked on an Eligibility List
- Hiring Agency Certifies the List
- Notification of Certification
- Interview
- Accept the Position

### Rule of Three

The Civil Service Commission operates under what is commonly known as the "Rule of Three.

- "The "Rule of Three" means that after an open competitive or promotional exam is held, the Appointing Authority may select any candidate from the top three ranks unless a veteran is in the top three.
- However, the "Rule of Three" is applied differently to Open Competitive Exams than to Promotional Exams.
