# University Senate Meeting Minutes University Senate Meeting #1, For AY 2011-2012 Monday, September 19, 2011, Margaret Williams Theatre

The President, Dr. Joseph Riotto, called the meeting to order at 3:30 p.m. Dr. Riotto asked for a moment of silence for two former employees: Dr. William Maxwell, former president of New Jersey City University; Carl Robbins, who was an Assistant to the President and served as Secretary of the Board of Trustees under four presidents. Also remembered were Michael J. Herbert, father of Dr. Christopher Herbert of the Physics Department who was an alumnus of Jersey City State College, and Megan Outlaw, the daughter of Mr. Willis Outlaw of the Public Safety Department.

President Joseph Riotto and the Senate Executive Committee thanked the NJCU President's office and Vice President of Academic Affairs office for making arrangements so that the University Senate meeting could take place immediately after the All-University meeting President Riotto thanked Joe Musco for working with the Senate to facilitate this event.

**State of the Senate**, a selective high level summary of Senate Activities that took place in the previous academic year (2010-2011) and represent an added-value level that the senate body has contributed to New Jersey City University:

- 1) Many presentations by faculty, administrators, staff and guests which kept the NJCU community informed and abreast of current events.
- 2) Approved and updated a countless number of courses, programs and new majors and launched itself into a new area. NJCU passed its first two Doctoral Programs. In addition, Graduate Studies and the Senate body approved 26 courses and 2 doctoral programs with the C&I Committee having received and reviewed 30 courses, of which 15 were approved.
  - Ad Hoc Committees were established to facilitate items of concern if not within the purview of standing committees.
- 3) Developed Senate Tracking Report to be available on the Senate web site.
- 4) Updated Forms and Procedures such as:
  - a) Permanent Course Approval Form (11-14-10);
  - b) Procedures for Creation of Undergraduate and Graduate Degree Programs (SACC approved 2-10-11).
- 5) In concert with Dr. Hernandez and Dr. Bruno, continued the combination of All University Meeting and Senate Meeting as one meeting to launch the Academic Year.
- 6) Updated various Senate Standing Committees by filling vacancies and filled a vacancy in Professional Staff Senator At Large;
- 7) Provided a forum to surface and communicate academic concerns;
- 8) Provided Senate representation on various university committees including the University Strategic Planning Steering Committee;
- 9) Provided a forum for updates on programs such as the new General Education program;
- 10) Senate presence and report covering the various SACC meetings (Feb 10, 2011 and April 7, 2011).
- 11) Time and effort on Senate standing committees, which provide the true life blood of the Senate, and whose work is truly appreciated.

The Strategic Planning Council will present a report of the start-up activities at the next Senate meeting.

President Riotto also offered congratulations to Dr. Deborah Woo, who has been appointed Assistant Vice President for Academic Affairs.

# VI. Campus Climate and Academic Collegiality

Dr. Joanne Z. Bruno, Vice President for Academic Affairs noted that although the university is under a difficult budgetary climate, no positions were lost and the number of full time faculty has increased, demonstrating our commitment to the academic core. Dr. Bruno requested that the university community continue to embrace its mission and keep the following values at the forefront:

- Openness and transparency
- Cooperation and teamwork
- Embracement of continuous change.

Dr. Bruno also noted that while there is shared governance, decisions have to be made. The appropriate processes can be followed when there are disagreements. Dr. Bruno welcomed continued discussion with the university community.

There were no new business items raised. The comment was made that there were old business items that should have been on the agenda. President Riotto stated that there were no outstanding items that were updated that could have been placed on the agenda other than those in standing committees.
