

FY25 BUDGET & AY24/25 TUITION & FEES

RESOLUTION RATIFYING A 3.5% INCREASE TO TUITION AND FEES AND ADOPTING THE FY25 BUDGET PLAN SUBJECT TO REVIEW AND ADJUSTMENT BY THE FIRST QUARTER OF FY25 AND QUARTERLY REVIEWS AND ADJUSTMENTS BY MANAGEMENT AND THE BOARD THEREAFTER

WHEREAS, the New Jersey City University (NJCU) is committed to maintaining the financial health and stability of the institution while providing quality education to its students; and

WHEREAS, the Board of Trustees recognizes the necessity of adjusting tuition and fees to meet operational costs and ensure the continued delivery of high-quality academic programs and services; and

WHEREAS, after careful consideration and analysis, it has been determined that a 3.5% increase in tuition and fees is necessary to support the financial needs and academic and business operations of the university for the Fiscal Year 2025 (FY25); and

WHEREAS, the attached FY25 budget has been developed to align with the university's strategic goals and priorities, yet it requires ongoing review and potential adjustments and recalibrations to respond to changing financial conditions and needs along with enrollment trends and to allow the new members of the Board a reasonable period to evaluate the budget forecasts and assumptions; and

WHEREAS, the FY25 budget includes state appropriated institutional stabilization aid in the sum of \$7 million conditioned on the State-appointed Monitor's assignment; and

WHEREAS, the Board of Trustees continues to acknowledge the duties and responsibilities of the State Monitor as prescribed under P.L. 2023, c. 115, and its designation as an "affiliated entity" to the university in accordance with MSCHE standards and policies, and state and federal law;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of New Jersey City University hereby ratifies a 3.5% increase in tuition and fees effective for the Academic Year 2024/2025; and

BE IT FURTHER RESOLVED that the FY25 budget plan is hereby adopted, subject to review and adjustment by the end of the first quarter of FY25, no later than September 30, 2024; and

BE IT FURTHER RESOLVED that the university management is directed to conduct at least quarterly reviews and adjustments of the FY25 budget as necessary, with

delegated review and control by the Board's Finance and Audit Committee, to ensure the financial stability and sustainability of the institution; and

BE IT FURTHER RESOLVED that the Board's Finance and Audit Committee shall oversee the implementation of this resolution, ensuring that all adjustments and reviews are conducted in a timely and transparent manner, with regular reports provided to the Board of Trustees.

Fiscal Year 2025 Proposed Budget July 15, 2025



NJCU

NJCU is investing to ensure student retention and success as the major goal of this budget.

Seventeen new FTEs with student facing responsibilities ranging from recruiters, counselors, financial aid specialists for Tag and Pell, academic advisors and registrars. These areas also have budgeted non salary increases.

NJCU's program to include books in tuition, to ensure all students have the books they need to complete their classes, is projected to cost NJCU \$2,000,000 next year.

The FY25 budget assumptions are as follows:

- 1) 3.5% increase in tuition rate & a 2% overall enrollment increase,
- 2) 3.5% COLA increase for all employees,
- 3) State stabilization aid \$7M
- 4) Capital expenses \$13.8M
- 5) Information Technology spending for technology
- 6) Reserve for additional debt service in FY26



- 5) Historic grants for Hepburn Hall
- 6) Increase the budget for capital spending.

The solution will need to be an overall combination of all these options.

RE: Fiscal Year 2025 Waivers of Advertising

The New Jersey State College Contracts Law requires that the University advertise for bids on all contracts for goods and services which exceed \$110,900. Exceptions may be authorized by the Board of Trustees under certain circumstances such as establishing contracts with vendors that are sole source providers and it is not practicable for the University to bid, or for the existence of proprietary products. In the last several years, in order to make the waiver process more efficient, the University requested pre-approval of the bid advertising waivers anticipated for the fiscal year.

The University is requesting approval of the waivers that are required for fiscal year 2025. Attached is a list of anticipated waivers and associated amounts from fiscal year 2024 and the related amounts expended, as well as a brief justification and the estimated expenditures for fiscal year 2024. While this list includes all anticipated waivers at this time, it is possible that additional waiver requests may be submitted during the course of the fiscal year if needed.

The University continues to proactively evaluate existing purchasing contracts to seek additional opportunities for bidding where feasible. It is the University's intent to continue to test the choice of vendors that we engage contractually by seeking alternate bids whenever possible.

BOARD RESOLUTION

BID ADVERTISING ANNUAL WAIVERS

FISCAL YEAR 2025

- WHEREAS: Pursuant to the New Jersey State Contracts Law (NJSA 18A: 64-52 et seq.) the University must advertise for bids on all contracts for goods and services which exceed \$110,9000 except under circumstances specified in the statute where bids may be waived, and
- WHEREAS: As permitted by the statute, the University seeks authorization of the Board of Trustees to contract without bidding with vendors that the University expects to do business within Fiscal Year 2025 because there are no alternatives and/or the State allows for waivers, and
- WHEREAS: Whenever and wherever possible, the University intends to test the appropriateness of dealing with any given contract vendor by seeking alternate bids for the goods and services with other vendors, if available, and
- WHEREAS: The University is requesting a bid advertising waiver for the attached list of such vendors and estimated expenditure amounts for Fiscal Year 2025 which will help ensure the continued efficient operation of the University, be it therefore
- RESOLVED: That the Board of Trustees of New Jersey City University on this 24th day of June 2024 does hereby approve the attached list of bid advertising waivers for Fiscal Year 2025.
